Thank you for participating in the User Group Survey that was distributed 2 weeks ago, we are greatly encouraged by the number and range of responses.

artsACT is compiling the survey results and will brief Government on your feedback and next steps.

Thank you for your productive participation in this and earlier processes. The designs have benefitted greatly from the level on input from residents and the understanding that the Project Team has gained about the unique role of GAC. For example we are in the process of identifying appropriate spaces for a Prayer Room, Baby Change facilities and accommodating Men's and Women's Business when needed to enhance inclusivity at GAC through these upgrades.

We are still working to the same *indicative timeline* that was distributed in Bulletin #1:

- Project team complete FINAL PSP April 2023
- Issue FINAL PSP to key stakeholders May 2023
- Commence detailed design April 2023
- Complete room data sheets with stakeholders May 2023
- Cost Final Sketch Plan (60% FSP) May 2023
- Appoint Project Manager June 2023

- Value management process (as required) June 2023
- Development Application submission (100% FSP) July 2023
- Development Approval December 2023
- Commence construction Early 2024
